(1) Complete the above entry form. Send it along with your entry fee(s) to the trial chairman no earlier than one month in advance.

(2) Registrations will not be accepted any earlier than 1 month prior to the trial date.

(3) Only 2 dogs may be entered per owner. A wait list can/will be started if someone is interested in running more than 2 dogs. If at 2 weeks before the trial date, the braces are not full, those on the waiting list will be called to fill the remaining spots. You will be allowed a 3<sup>rd</sup> dog provided that dog is entered in the Novice Division.

(4) Registration will close one week before the trial date unless the trial is not yet full.

(5) Professional trainers/handlers cannot register in the Novice Division. This Division is for new members, amateur handlers, and puppies or dogs just starting out. The objective is to ensure that new members and amateur handlers have a Division that they will be comfortable running in and not feel like they have to run against well-seasoned handlers and dogs.

(6) We will have designated mentors available to walk the field with anyone who would like one, or members may choose another amateur handler to go with them.

(7) NOVICE will run after the CGDA OPEN in that field.

(8) Rules for all field trial are available in the clubhouse and posted on the web site.
